Footnotes

GUIDING HAND shared the lead two wide in hand, was roused on the second turn, moved clear entering the lane then gradually opened up under hand urging. PERSHING hesitated at the start, spotting the field several lengths, trailed from well outside, in paths four to six through the second bend, was all out in the lane and got the nod for second at the wire. MAJESTIC STREAM progressed toward the outside on the backstretch, was three and four wide taking the second turn, rallied with PERSHING from just inside and was narrowly outfinished for the place. PUTTHEHAMMERDOWN prominent from path three, vied for the lead on the second turn, could not stay with GUIDING HAND upper stretch and slowly wore down the final sixteenth. WAIT IN LINE in paths two or three most of the way, lacked the needed stretch bid. FLEET DEPUTY pressed four or five wide for six furlongs then began to flatten. DE BRANDON BOY contested the pace from inside to the second turn then tired.
