Footnotes

SAINT STREET pressed the early pace racing off the rail, gained the advantage between rivals, edged clear at the top of the stretch and was best late. KARENS PRIZE prompted the early pace four wide, angled in some near the quarter pole, then shifted outward bumping into SAINT STREET at the top of the stretch, was steadied then went evenly late. RECKLESS PATCH was unhurried early, rallied three wide, showed some effort late and was along for the show. GHOSTLY MOMENT was outrun early, went four wide and gained steadily. ICED was off slow early racing off the rail and placed a mild bid late. TANDJUSTICEFORALL was forwardly placed early, went five wide at the quarter pole, placed a brief bid then went evenly. SHOVUNDA raced mid pack and lacked a closing response. ROWDY LILLY was void of early speed and passed tiring foes late. WIRED FOR HOME was within striking distance early, placed a bid then came up empty in the stretch. CHIMES GHOST improved her position in the stretch. SILVER PERSUASION retreated steadily after a half. SANDIA'S SECRET showed some brief speed, then dropped back and was eased to the wire and walked off. The rider of KARENS PRIZE claimed interference at the top of the stretch against the rider of SAINT STREET and after reviewing the films it was determined there would be no change.
