**Footnotes**

CALVARY'S BROTHER bumped at the start, soon had the lead, showed the way just off the inside, drifted out some midstretch, was all out and held on. BERMUDA SUNSET crowded at the start, was without early foot off the inside, three wide on the turn, angled in some entering the lane, was blocked upper stretch, altered inside CALVARY'S BROTHER with a furlong left, closed well and was clearly second best. NOTIME TO BADINAGE broke outward, bumping CALVARY'S BROTHER, was settled inside, angled out to path three leaving the turn, altered his path twice through the lane but caught JACKS THE LAW for third near the wire. JACKS THE LAW drifted out shortly after the start, bumped JUST GO GUSTO, pressed CALVARY'S BROTHER from just outside, floated out to path entering the stretch and did not have enough left. PAIUTE bumped after the break, pressed from outside, took the turn four then five wide, wore down in the stretch and lugged in late. WEST OF TEXAS was a brief factor off the inside, angled in on the bend and was empty for the drive. CLASSIC MOVER was away somewhat slowly and soon far back, angled in on the turn, came off the rail some for the stretch run and had little to offer. JUST GO GUSTO bumped and forced into PAIUTE after start, was forwardly placed between horses, three wide on the turn, faded leaving the bend, fanned out widest then continued to give way.
