IRISH DANCER stalked the early leaders four wide, sustained a bid to draw clear at the three sixteenths and held a safe advantage to the wire. PAPA G. T. broke sharp to set the early pace, was challenged in the turn and failed to match strides. JOHNNY'S SLICE was unhurried early, went six wide in the stretch and showed some interest late. INDY'S ROCKET moved up to challenge the leader into the turn but was finished early and weakened. CERTIFICATION was unhurried early, went five wide late and lacked a bid. K COURT was well off the rail trailing the field and was not a factor. PER RULING DATED 3/30/13 RECEIVED FROM THE NEW MEXICO RACING COMMISSION (RULING #2854513) CERTIFICATION WAS DQ'D DUE TO A POSITIVE TEST.
