**Footnotes**

LEMON CUSTARD was within striking distance early racing along the inside, angled three wide into the backstretch, rallied into the second turn and drew clear in mid stretch. AMPELIO (IRE) was unhurried early, went four wide into the stretch, showed some effort late and finished willingly. FREESGOOD chased the early leader three wide, placed a brief bid at the top of the stretch then flattened in the drive. NO WALKIN' JOE raced mid pack early saving ground, angled five wide and lacked a gain late. SPELLING BEE JONES was outrun early saving ground and failed to threaten. A LOT OF MON was void of early speed racing off the rail, angled out six wide and lacked a bid. SEA LEVEL set the early pace drawing clear, was used up after a half then retreated.
