JADED DREAMS pressed the early pace, went four wide to place a bid, gained a clear lead, was challenged briefly in the second turn, responded to pressure and kicked clear. ONE FINE JEWEL was unhurried early, sustained a steady effort, went along the inside at the three sixteenths, drifted out in the stretch and went evenly late. BOOGER BOO was outrun early, went five wide to rally and was along for the show. MAX BEAN was forwardly placed early, went four wide, vied nearing the three sixteenths then came up empty in the drive. DEITY was off slow early racing four wide, angled in to save some ground and placed a steady effort. DESERT GULCH showed little, went five wide in the stretch and lacked a gain. JOHN PEARL made a middle move then gave way. AMOROSO raced mid pack saving ground, angled five wide and lacked a bid. NEW MEXICO KID failed to threaten. HIGH RIDGE RUNNER dueled from between rivals, angled in to save some ground then faded in the stretch. CATRON COUNTY showed early speed along the rail then stopped and was eased.
