KOMAX advanced five wide, dueled, put those rivals away and surged clear. EXCESSIVE CONTACT was boxed in on the turn, altered out five to six wide and closed well to get up for second. NEW STEP was well placed, advanced four wide between, dueled and weakened late. REGAL OKIE was unhurried, altered out and closed belatedly. JOSHUA JUDE was the early speed inside and yielded. EXCESS SUMMER was forwardly placed and gave way on the rail. GONDOLIERI (CHI) showed early speed, came three wide between and tired. ARCHIE'S DREAM saved ground, carried wide out of the turn and was no threat. P F DECO broke out, dropped back and drifted out in the stretch.
