### Footnotes

CAKE AND CANDY rated on the front end just off the inside, moved clear when allowed on the second turn and maintained full control under steady handling through the stretch. SPARTAN WARRIOR was urged along to stay close outside CAKE AND CANDY, followed that one into the second turn, swung out to path three as he took over second entering the lane, was no match for CAKE AND CANDY, moved to the inside after entering the final furlong and held off SAPELLO CANTADOR for the place. SAPELLO CANTADOR settled early, gradually progressed not far off the inside, moved to the rail for room nearing the quarter pole, floated out some entering the lane, took over third, angled out further midstretch and was drifting out some as he close the gap on SPARTAN WARRIOR in the waning yards. DESERT GULCH progressed to contention just off the inside on the backstretch, could not stay close on the second turn, swung out five wide for the stretch run and made up minor ground the last eighth. DEITY moved up from outside to race in the second flight on the backstretch, began to fade three wide on the second bend, was steadied briefly when DESERT GULCH crossed his path entering the stretch and had little left. REAL FLAXY blocked briefly, got through along the rail to gain the advantage leaving the first turn, could not stay with CAKE AND CANDY on the second turn and flattened out for the drive. DAN THE CON MAN void of speed between rivals, was widest taking the second bend and had no late bid. CARACAL ERA inattentive at the break, was off a couple strides after the rest, moved up some from outside leaving the first turn but steadily gave way before finishing a half mile, was eased in the lane and walked off.
