PLEA AGREEMENT was off slow early, began to close the gap into the second turn, then rallied to gain command at the sixteenth pole then drew off and was vanned off after pulling up. HEZAMAZING showed early speed, drew clear down the backstretch along the rail, held to mid stretch then was challenged and was no match late. HURRICANE LAKE was unhurried early racing six wide into the first turn, went three wide nearing the three sixteenths and finished belatedly to gain the show. IMCO SPIRIT (IRE) was allowed to settle early, went five wide to place a bid near the five sixteenths then flattened. VAMOOSE was forwardly placed early saving ground then weakened. INHISGLORY raced mid pack five wide then gave way. WARSHAW chased the early leader then retreated steadily.
