Footnotes

AMOROSO pressed the early pace, sustained a bid to edge clear, drifted out in the stretch late and widened. NEW MEXICO KID was within striking distance early, angled four wide between foes in the stretch and showed some effort late drifting out. SUAVEY was forwardly placed early, vied five wide to be within contention at the eighth pole then flattened. ARROWCOCITY was unhurried early, swung out six wide near the quarter pole and showed some interest late. MYSTICALUNDERTONES was outrun early racing well off the rail, circled the field into the stretch and placed a mild bid. DIXIE BANDJO was

void of early speed and passed tiring foes in the stretch. K O JUSTICE moved up racing off the inside to set a pressured early pace then gave way in the stretch. SECONDCHANCEROLL rushed up to show early speed before the first call then faded steadily thereafter. RUN RILEY RUN showed little racing four wide in a dull effort. TRICK RYDER raced mid pack saving ground then retreated. The rider of NEW MEXICO KID claimed interference against the rider of AMOROSO and after reviewing the films the Stewards determined there would be no change.
