BIGMIKEISTHEMAN broke alertly, shared the lead from outside, two wide taking the turn, was roused upper stretch, lugged in a bit near the eighth pole and moved clear nearing the final sixteenth. BRAVE JULIAN contested the pace inside BIGMIKEISTHEMAN, was steadied slightly when the latter came close midstretch, no match for BIGMIKEISTHEMAN deep stretch but was unchallenged for the place. BUBBA WHO prominent from inside, swung out three wide on the turn, drifted out some after entering the last furlong and narrowly held onto third. PREMIER IMAGE chased from between horses, was just off the inside taking the bend, lodged a mild bid in the lane and closed the gap some. LAMBSHEAD failed to keep up five wide taking the turn but improved position some without threatening in the stretch. GONE SMOKIN trailed from outside, advanced just off the rail on the turn, swung out six wide entering the stretch and steadily advanced. PERKINSVILLE swung out on the turn, was widest into the lane and gradually drifted out the last furlong. ROCKIN HARBOR without speed just off the inside on the backstretch, progressed along the rail through the turn and upper stretch then leveled off. SOONER BLUE chased just off the inside, swung out four wide for the drive, began to yield and was angled in when his path was taken deep stretch. LOUZADO void of speed from outside,

was four wide taking the turn and had no late bid. DOMS TRICK also void of speed, stayed well off the inside through the bend, angled in for a clear path upper stretch but had little to offer. T V COMIC also soon well back while between rivals, moved to the inside entering the bend and steadily gave way.
