### Footnotes

STEPPIN sent to vie for the lead between rivals, was two wide through the turn, roused again at the head of the lane, moved clear and maintained full control under a mild drive. ELLENSONG contested the pace just off or along the rail, was no match for STEPPIN when set down for the drive but was clearly second best. TIZABERRY showed first, dropped back from outside, angled in two wide on the bend, had the rail entering the lane, came off the inside some for a clear path just inside the last furlong, battled for third to the wire and prevailed. POINT OF PRIVELEGE urged along from outside, was three wide taking the turn, fought for the show through the lane, did not have enough left but was clearly best of the rest. ROY'S RICH LIZZI angled toward the outside early, was four wide through the turn and failed to have a stretch bid. GARDEN TREASURE a bit awkward and slow at the break, chased from inside, came off the rail some leaving the turn, angled out further upper stretch and lacked a significant response. BLUE JEAN'S WHO forwardly place from path three on the backstretch, gave way along the rail on the turn. WINTER PEARL soon trailed, was just off the inside entering the bend, floated out to path four into the lane and had little to offer.
