**Footnotes**

GENTSFINISHFIRST stalked from between horses, moved clear just off the inside on the bend, drifted out entering the lane, gradually lugged back in and held off CONDOBOUND under steady urging. CONDOBOUND pressed from outside, angled inside GENTSFINISHFIRST entering the lane, threatened, finished evenly but was clearly second best. TROUBLE RULES bumped from the rear shortly after the start, advanced three wide through the bend, gradually lugged in as he battled for third and shook off MR. PINDTER (MEX) late. MR. PINDTER (MEX) chased from outside, lost ground four wide taking the turn, also lugged in through the stretch and was weakening in the waning yards. AMEN BABY forwardly placed between horses, faded two wide on the turn. DELATORE bumped TROUBLE RULES shortly after the break, was checked, lost ground, passed some tired ones upper stretch then finished evenly. GAMBLING MAN a step slow at the start, showed no speed between horses, was four wide entering the lane and lacked significant stretch response. SEA BATTLE chased from inside, faded on the bend, floated out some into the lane and had little left. GALLERY OF STORMS moved clear nearing the end of the first furlong, took the inside but tired leaving the turn.
