Footnotes

ME A PACHE was outrun early, rallied into the turn closing the gap, split foes three wide near the eighth pole and closed with a rush to just get up in the final stride. SPECIAL DEPUTY moved up splitting foes to force the early pace, vied into the stretch to gain a clear advantage at the eighth pole but was outfinished in the final strides by a fast closing rival. CIMARRON BULL was within striking distance early, went three wide in the stretch placing a mild bid and gained the show. SAVAGE SWEATER was unhurried early, raced wide throughout and showed some interest late. CRAFTY TIMMY raced mid pack into the stretch racing off the rail and placed a mild effort. WISHNDONTMAKEITSO was forwardly placed early between foes then weakened. TALK TO ME CHOPIN broke slowly at the start, then settled into stride four wide and lacked a gain late. A CLEVER DOME saved ground to no avail. NO TRICK raced wide and was not a factor. LORD IMAFASTCAT was hustled away down the backstretch four wide and was finished after a half. SANDIA HARBOR showed early speed along the inside, was used up early and was empty in the stretch. BULL IN EXCESS dropped back early racing well off the rail and was never a threat.
