### Footnotes

MCKENNA'S JUSTICE pressed the pace early, then dueled for the lead through the turn, then drew clear down the stretch for a driving finish. MILLER'S TIME was mid field, then rallied, five wide to get up for place. CASA O stalked the pace, then angled out at the quarter pole and closed. C'EM BLAZIN was unhurried early on the rail, angled out at the quarter pole and rallied late. DISTURBINGLY HOT dueled for the lead on the turn with an inside trip but gave way at the eighth pole. NEWTONS THEORY dueled for the lead through the turn going three wide but faltered down the lane. ELKHORN CREEK dueled for the lead through the turn, two wide but dropped back at the eighth pole. HARLAN COURT was near the back, four to five wide with no late run. BENDANIE trailed the, two wide and never fired.
