DEITY unhurried early, raced wide throughout the back stretch, advanced six wide into the second turn, made a bid for the lead at the eight pole and drew off. PAID IN FULL tracked the leaders, advanced four wide into the second turn, made a bid at the eighth pole with the winner and was a clear second.

CHROME BOY stalked the leaders, while saving ground, made a bid at the quarter pole and faded in the drive. BAY TIME FRIENDS raced mid pack, angled out six wide into the second turn and had a belated bid. SAPELLO CANTADOR raced in the middle of the pack and had no bid in final furlong. WHO LEFT WHO tracked the early leaders to the quarter pole, and weakened in the drive. ANZIGER set the pace to the six furlong pole and steadily faded. BOOGER BOO was unhurried early, and was empty throughout. CATRON COUNTY was far back early and remained far back. CROWNTHATBIRD trailed throughout and was never a factor.
