Footnotes

BREA fractious in the post parade and behind the gate, was kept close between rivals once the race began, three wide on the turn, gained the advantage midstretch, was urged clear then finished the last seventy yards in hand. AMY'S LYIN showed first, stalked JUST TELL ME from just outside, took over two wide leaving the turn, could not hold off BREA inside the last eighth but was clearly second best. CABRIOLA hustled up from outside on the backstretch, was four wide through the bend, battled for third in the lane and edged ahead late. MICAELA forwardly placed toward the outside, angled in to be just off the rail with a quarter mile left, fought for the show through the stretch but did not have enough left in the waning yards. BACK SEAT MOVES trailed, picked up her pace just off the inside on the turn, fanned out some leaving the bend, bumped with FANTASTIC STRIKE when caught in tight quarters at the top of the lane, was forced out just after that then gradually angled in as she progressed the last eighth. RED ANT exchanged bumps with TRICK FALLS at the start, was angled outside at the half mile marker, widest leaving the turn and failed to have a late bid. TRICK FALLS exchanged bumps with RED ANT at the break, saved ground taking the turn and only passed tired ones in the lane. EL SANCHO'S JUDGE broke inward, bumping JUST TELL ME from the rear, was steadied, in paths three then four through the bend, forced out shortly after entering the lane and had little left. FANTASTIC STRIKE soon backed up between horses, was just off the inside leaving the turn, bumped with BACK SEAT MOVES at the top of the stretch, was checked and altered out to avoid JUST TELL ME after that and did not recover. JUST TELL ME bumped from the rear at the start, soon had the lead, began to give way from inside leaving the turn, floated out some entering the lane, was pulled up and vanned off in distress. There was a stewards' inquiry into the bumping and altering that went

on upper stretch but no action taken after their review.
