LEONAS TR vied, lugged in midstretch, bothered foes-dq, drew away, driving. BESTFOOT FOREWARD vied, no match for winner late, held 2nd. RARE I AM vied, not enough left. OKLAHOMA DASHER stumbled start, vied, not enough left. EYE MY STOCKS pressed, no late bid. MAJOR PASSION away slowly, cut off midstretch, checked. GUAJILLA took some bad steps early. EYE OPENED EXPERT drifted out some 3/16, brief speed, tired. SAFEHAVEN crowded early, cut off 1/8, checked. JESS GETTINIT DONE blocked early, no late bid. There was a stewards' inquiry and objections lodged by the trainer of SAFEHAVEN and the rider of MAJOR PASSION claiming interference from LEONAS TR midstretch. After the stewards' review, LEONAS TR was disqualified and placed ninth.
