RENTS PAID was forwardly placed going three wide, then rallied in the turn and drew off late for the win. PIERRE BEAR made lead, but gave way at the eighth pole to hold on for place. HARLAN COURT chased the pace on the rail, then offered a bid and held on for third. CASA O was near the back and had a mild bid up the rail. SMOLDER was mid pack going two wide with a mild rally but hung late. MILLER'S TIME was in the middle of the pack, three wide, then showed mild interest in the turn only to flattened out down the lane. ARABIAN DANCER was unhurried early on the inside and lacked the needed late response. DEACON'S CAT was four wide throughout and through after the half.
