Footnotes

SOUR GIRL set a pressured early pace racing just off the inside, edged clear into the stretch and widened. LYNDEE K chased the early leader, angled out between rivals at the top of the stretch to place a bid but was no match late for the winner. TIME FOR DECEPTION was within striking distance early, went three wide, lacked a gain late but held the show. PRECOCIOUS ORPHAN was close in the early going four wide, lost ground into the turn then came back in the stretch late. SEA MELODY was unhurried early, gained steadily, altered inward mid stretch then flattened. PLUM FAST raced mid pack while saving ground and lacked a late response. ICED forced the early pace four wide and was finished after a half. DOLLY DRONE dropped back early, went four wide and lacked a late effort. ROWDY LILLY was jostled at the start, went four wide and failed to menace. COURTLY PROSPECT was off slow early and failed to threaten. RAPID FIRE broke slowly, saved ground and showed little. GROOMS DIAMOND trailed the field and was always outrun.
