WHO RAE pressed, weakened. FLIGHT OF FURY chased, steadied near wire. G MONEY no mishap, even effort. DD MAGIC JACK no mishap, even effort. IMA CRYIN OVER YOU no mishap, no late bid. DASHIN LION no mishap, no rally. DINERO FOR DINERO stumbled badly start, bumped. The trainer of DESERT DELIGHT CASH lodged an objection alleging interference from RS CORONA FIRST and the trainer of FLIGHT OF FURY lodged an objection alleging interference from both DESERT DELIGHT CASH and RS CORONA FIRST deep stretch. After their review, the stewards did not uphold either claim of foul.
