BEAT THE DEVIL stalked the pace of ANALYZED, called on that foe three wide at the quarter and dueled her into submission going past midstretch, then drew off under a hand drive. GALLANT VENTURE tracked the early leader from inside, angled three wide into the stretch for clear sailing but had to steady to avoid a tiring KIMMERS, altered out another path, rallied and gained second a sixteenth out. LOVELY JESSICA was taken back early, rallied along the rail and got up for the show fifty yards out. ANALYZED set her own pace from the two path, fought back when challenged into the stretch but weakened in the final eighth. T J MAC RANS passed tiring foes five wide in the lane. KIMMERS tracked the pace around the turn, bid four wide at the quarter to loom a threat but flattened out in the drive. CAL BRITE settled back off the speed, angled four wide in to the stretch but failed to have a rally. SAN DIEGO STINT chased the early pace three wide but was on empty in the stretch.
