Footnotes

EL LOCK O' settled, picked up his pace just off the inside after a half mile, bid along the rail through the second turn, had the lead as he floated out some leaving that bend, moved clear in the stretch, began to drift out after entering the last furlong but held on. CALL IT A NIGHT rated toward the outside the first half mile, commenced his bid nearing the second turn, was four wide through that bend, battled for second in the stretch and was forced out late by the weakening leader. DRY GOLD away slowly, stayed well off the inside through the first bend, progressed widest on the backstretch, was roused after a half mile, his rider lost his whip while five wide on the second turn, fought for second in the lane and was also forced out some deep stretch. GLENWOOD AUGGIE settled not far off the inside, also began his bid after a half mile, was two then three wide taking the second turn, gradually angled out trying to gain a clear path as he rallied in the stretch, was steadied briefly in the waning yards and altered in. STORMING SPIRIT broke in stride, was soon chasing HEARING VOICES from outside, went for the lead from path three on the second turn but slowly yielded in the stretch. CATRON COUNTY in contention just off the inside on the first turn, steadily faded from inside once on the backstretch, floated out some entering the lane, moved back to the inside upper stretch and had little to offer. HEARING VOICES a bit slow at the break, altered to the rail into the first turn, quickly moved clear of the rest, showed the way in hand just off the inside on the backstretch, was challenged leaving the second turn and flattened out for the drive. There was a stewards' inquiry into the stretch run but no action taken after their review.
