TAKE ME IF YOU CAN unruly gate,bumped start,drifted out inside 1/16,bothered foes-dq. DASH OF THIS N THAT lugged in twice early, clear, outfinished. SENTENCED AGAIN bumped start, steady drive, held 3rd. MR BLACK VELEVET chased, bumped, checked 70 yard pole. CHASE A ROON dueled for 2nd, altered out inside 1/16, bumped, checked late. EVIL HOUSE MIRACLE bore out start, steady drive, gained. SHOOTITSHOT away slowly, steadied behind traffic, altered out, evenly late. LLUVIA LIGERA FIRST altered in early, jostled, checked hard, lost all chance. NOAH BLUE forced in early, jostled, checked hard, lost all chance. There was a stewards' inquiry into the race. Also the riders of CHASE A ROON and MR BLACK VELEVET lodged an objection claiming interference TAKE ME IF YOU CAN deep stretch. An objection was also lodged by the rider LLUVIA LIGERA FIRST alleging interference from DASH OF THIS N THAT upper stretch. After their review, TAKE ME IF YOU CAN was disqualified and placed fifth and the claim against of DASH OF THIS N THAT was not upheld.
