THE STEEL WAVE vied, gradually drifted out, got up. SEISES ROYAL vied, all out, 2nd best. SNOW FORECAST bumped start, altered path twice, got 3rd. BRIMMIN TO PASS bore out early, bothered rival-dq. OCEAN BOUND squeezed early, mild bid, hung. ESPECIALY OKEY forced out early, steadied, altered in, no late bid. TEASE PLEASE no mishap, no rally. TRACK FORTY FOUR bumped start, steadied, no factor. CLASSY J chased, weakened. ZOOMAGE unruly gate, broke in air, outrun. The trainer of ESPECIALY OKEY lodged an objection claiming interference from BRIMMIN TO PASS shortly after the start. After their review, the stewards disqualified BRIMMIN TO PASS and placed him sixth for that interference.
