GLORY PARK raced well placed early, bid outside the leader into the stretch then after dueling with that one to late, shook clear under pressure. SNOW FAIR set a solid pace, resisted to late when challenged then saved the place. VIV'S TIARA was also well placed, bid in the furlong grounds but was outkicked late. TUOUBLIERASMONNOM made a middle move through the second turn to bid into the furlong grounds before hanging late. ANIME was boxed and checked inside through the second turn, swung six wide for racing room then offered a mild rally once clear. FLY UNITEDLY raced evenly. ROAR OF THE KITTY was no factor. WHY WHY WHY AMOUR also turned in an even effort. HELL 'N MAY failed to menace. IDON'TKNOGOASKANNI was no factor.
