I LIKE IT stalked the pace inside, got through along the rail to challenge into the furlong grounds but was outkicked late. APPEALING CAT raced close up outside early, bid after five furlongs then slowly weakened. BRINCA was no factor. SKY GLOW chased to the quarter pole then gave way.
