NATALICAT angled inside early to stalk the pace, swung three wide out of the turn then rallied past the leader through the furlong grounds to be along in time. EXCESSIVE HEAT dueled between rivals, gain a short lead into the stretch then resisted past mid stretch before weakening while saving the place. HELLO AGAIN broke slow, got through inside in upper stretch then was gaining late. GIVONNA ALYSSA vied three wide early then gradually weakened. DEFIANT DARLING passed tiring rivals. DISCO DAMSEL dueled early then gave way. ZORI'S EYE raced evenly. LUCKEE MATCH vied for the early lead four wide then faded. GRAEMY was no factor. WHISPER OF LIGHT showed little.
