OK DEPUTY chased the early leaders, took over in the turn then moved away leaving the furlong marker when asked. MR GUSKA was never far back, moved to striking distance in the furlong grounds but was no match for the winner while outfinishing the rest. SO SMOOTH looped rivals four wide but failed to sustain that rally. BUSHY'S YIELD was roughed up between rivals in upper stretch then made up some ground inside. FIREONTERANGE made a middle move then flattened out. COURT ORDER was fractious in the gate then gradually weakened. J'S SUNDANCE HALO was blocked through the turn then again inside in the stretch. HEFFERMAN raced evenly. LET ME LOOSE pressed the issue into the turn then was bumped in upper stretch while tiring. REDIFUSION was used up disputing the pace then bore out into BUSHY'S YIELD in upper stretch. OYSTER SLEW was no factor. LAMBETH stopped.
