NICKLAUS WAY allowed to settle, moved up on the two path through the second turn, bid on that path into the stretch, then closed fast through the lane and edged ahead in the final strides. SUPER CHUNKY stalked the pace on the outside, bid outside of that one into the stretch, then drifted out, bumped BLAMESHIFTER and missed under steady right hand urging. CLEAR ATTEMPT mid pack and inside, moved up three wide through the second turn, angled in and came through inside of rivals into the stretch, gained a short lead and weakened late. BLAMESHIFTER mid pack and outside, looped up four wide through the second turn, fanned widest into the stretch, then was bumped, carried out and missed. MELLOW FELLOW sprinted to a clear lead soon after the start, stayed on when challenged into the stretch, then faded the final furlong. BIG SKY POSSE was no factor. A STEWARDS' INQUIRY AND CLAIM OF FOUL LODGED BY THE RIDER BLAME SHIFTER AGAINST THE RIDER OF SUPER CHUNKY WAS ALLOWED FOR INTERFERENCE IN THE STRETCH RUN.
