SCHOOLYARD DREAMS chased the leader early, bid outside that one in the second turn to gain a short lead then dueled with AFRICAN MOON past mid stretch before shaking clear late. AFRICAN MOON was never far back, bid after five furlongs then dueled with the winner to late before hanging while second best. C C'S PAL raced close up early, bid four wide leaving the second turn then weakened in the drive. SIR BACCHI failed to menace. DUKES COUNTY set a slow pace for six furlongs then gave way. TEETEE'S TAPIT was no factor. SARAVILLE trailed.
