LUPO stalked the pace into the stretch, split rivals in the drive to loom boldly late before just missing. TURWADA chased inside, got through along the rail to challenge for and gain a clear lead a furlong out then hung. BLACK BELT set the pace early, came back on again in the drive but was outkicked. RIGHT TO BURN passed tiring rivals. CAT SONATA raced evenly. COURAGEOUS CAREY was no factor. SPECIAL NEEDS showed little. REPENT AND REJOICE stopped. DADE CITY bolted in the turn.
