BOBBY'S BELL made a four wide middle move, challenged outside in the drive and wore down the leader late. REGINA TWAIN stalked the pace inside, got through along the rail into the stretch to gain a short lead only to be collared late. MIS MAX fanned five wide out of the turn then was making up some ground outside late. CONNIE'S JUNE MOON angled to the middle of the track after a half but lacked a strong late response. LAWYER JEN set a solid pace for a half then gave way. ESSENCE OF TIME failed to menace. GET YOUR SHINE ON chased early, bid into the stretch then flattened out. REPENT'S GEM was hung wide and was no factor.
