REBECCA'S CHARM was hung five wide while prompting the pace for three furlongs, went up to challenge for the lead out of the turn, shook off a bid from EXPECTED ROLL through the furlong grounds then edged clear late under brisk handling. EXPECTED ROLL was boxed for a bit on the turn, got through inside to challenge the winner through the furlong grounds but hung late while best of the rest. FORUM SEARCH dueled to the stretch then gradually weakened. UMPATEEDLE made an inside middle move to mid stretch then weakened. SISTER PONCHE passed tiring rivals. EASE AHEAD raced evenly. SHRIMP TEMPURA failed to menace. STRAIT FROM TEXAS was through after a half. CALL ME ELIANE was used up disputing the pace and stopped after a half. CINNAMON BUNS vied to near the quarter pole then also stopped.
