### Footnotes

SEATTLE'S LAD broke sharp to gain the early lead, set a fast pace into the stretch then continued well through a long drive to prevail under strong handling. LUNA DEL GATO chased for a half, angled inside in the drive then was slowly gaining on the winner late while easily second best. SPARKLING SPRINGS was void of speed for three furlongs then made a mild rally late. NORTH POINT was well placed into the stretch then weakened. DAMASCUS LIGHT failed to menace. SUNNY SALUTE was no factor. STRAIGHT PASSION was through early. REPRISAL stopped. TOOTAINED stopped.
