MAUDIE MAY void of early speed, fanned eight wide for the drive then after drifting in slightly through mid stretch, drew clear late. VERI TERRI made a middle move in traffic, swung six wide, steadied briefly as the winner past her in mid stretch then was outfinished late. RITZEE ROYAL CROWN was blocked and taken up behind rivals on the second turn, angled to the far outside in mid stretch then closed a gap late. MY NAME IS MARY vied for the early lead, dropped back after six furlongs then bore out into rivals in mid stretch. PROUD SALLY dueled to mid stretch then weakened. MAJESTIC MOOD made a middle move then was bumped and in tight in the stretch. TWIST MY HEART stalked early, bid after six furlongs then was in tight while tiring in the drive. SNOW BEAUTY made a middle move and came up empty. JOVIAL NOTE was well placed early then faded. TANKED dueled then was roughed up while giving way in the drive. Following a stewards inquiry MY NAME IS MARY was disqualified and placed last for interference in the stretch. A claim of foul by the rider of VERI TERRI against the winner for interference in the drive was disallowed. The portable inner rail was set at 12 feet and the race was hand timed
