HE'S APPEALING stalked the pace inside, got through along the rail to challenge into the stretch, shook clear inside the final furlong then just lasted late. MOUNT SKYLIGHT raced close up from the outset, bid four wide out of the turn then was slowly gaining on the winner late. TAKE IT HOME DON rushed to the front inside, resisted to mid stretch then slowly weakened. RED RANGER made a middle move then made up some ground late. GAMBLIN' JERRY lodged a mild belated bid. BROWN FEATHER made a middle move to mid stretch then gave way. REPRISAL was well placed early then faded. MR. SEABRA was through after a half. TUFUO was hung five wide then faded. PONTIAC GEORGE failed to menace. LUXEMBOURG turned in a dull effort then was vanned off.
