CERTAIN APPEAL chased the leader from the outset, bid outside that one into the stretch then dueled through a long drive before narrowly prevailing under strong handling. EXTENDED FAMILY rushed to the lead outside early, set a fast pace under his own courage then resisted when challenged through a long drive and just hung late. PROFESSORPLUMDIDIT made a middle move then was slowly gaining inside. THE ONE THING made a middle move to mid stretch but was outkicked late. READY FOR RAY raced evenly. SEA FIGHTER passed tiring rivals. CHILL OUT CAT raced evenly. ADRIATIC was no factor. SOMBREADO showed little. ROBIN DIAMOND was no threat. SURPRISEDTOSEEME failed to menace. HOW TO KNOW stopped.
