ASK JOE set the early pace well off the inner rail, held a short lead into the stretch, was headed through the furlong grounds but came back on again late to edge clear. LIEUTENANT DAN raced well wide to the stretch then was steadily gaining late outside. SCHOOLYARD DREAMS angled inside early to stalk the pace, got through along the rail to challenge for and gain the lead a furlong out only to hang in deep stretch. TAXES FOR BEN was well placed a furlong out but was outkicked late. WHISKEY TAP pressed the winner to the stretch then weakened. RICKYONThERUN failed to menace. BEIJING HOUSE weakened gradually. JUDGE BREW showed little.
