DAISEY LEE raced close up early, bid five wide in the turn then shook free and pulled away late under pressure. VICTORIA DRIVE broke slow, was steadied briefly behind rivals while trying to advance in the turn then lodged a belated bid for the place. FLY TO GLORY raced close up early, bid four wide in the turn to draw even for the lead then weakened in the drive. DOUBLE FIVES stalked the pace inside, got through to draw even for the lead after a half then faltered. ASWEETKITTY passed tiring rivals. CARSONCITYCOUNTY was hard used disputing the pace for a half. LIPSTICK 'N DESIRE raced evenly. FOXY VALLEY GIRL failed to menace. GERALDINE'STHUNDER was no factor. CLEOTA showed little. SULTRY GIBSON stopped.
