BALINO set a moderate pace, drew off a bit leaving the second turn to mid stretch then was all out to narrowly prevail. FESSED UP raced close up from the outset, was boxed through the second turn then angled off the rail in the drive and finished stoutly to just miss. RIGHTEOUS PLACE made a middle move, bid four wide in the drive but was outkicked late. OVER AND BACK was boxed in the second turn, angled inside in the drive then was gaining late. TELITIKITISCOACH passed tiring rivals and was vanned off. RUN TO CLASS failed to menace. TORI'S GUY chased early, bid in the second turn then weakened in the drive. PYRITEDAN was no factor. TIGER DISTINCTION pressed the pace then stopped.
