IMAGE OF APPROVAL was unhurried early, fanned outside out of the turn then ran down MOMENT OF SONG in the late stages. MOMENT OF SONG chased the early leader, bid out of the turn, shook free leaving the furlong grounds but hung late while best of the rest. HARPERS CROWN was forwardly placed but lacked a strong late response. NUMATTIC sprinted clear early, set a fast pace then resisted the winner past mid stretch before weakening. BIANCO APPEAL failed to menace. BIG BROKEN STRAW was well placed inside for five furlongs then came up empty. BEST CALL was through after a half. PILSNER was no factor.
