**Footnotes**

HENIN was unhurried early, looped five wide out of the second turn to challenge and draw off and was clearly best. INQUIRING made a middle move, was blocked and forced to wait out of the second turn then angled out four wide and finished willingly to be second best. BAB'SBRICKHOUSE checked and steadied along inside to the stretch then bore out through the final furlong despite right hand pressure. THE ADJUDENT stalked the pace for six furlongs, bid into the stretch to lead briefly then was carried out and steadied late. KISSES REQUIRED pressed the pace into the stretch then weakened. BEND A SILVER set a moderate pace then gave way. TOOTSIE'S GIRL raced evenly. ROKEYBY BABY was hard to load. SEVENTYSEVEN SUSHI showed little. A claim of foul by the rider of THE ADJUDENT against BAB'SBRICKHOUSE for interference in the stretch was disallowed.
