**Footnotes**

CHOCOLATE THUNDER vied for the lead from the outset, shook off PURPLEGREENANDGOLD leaving the second turn to move into the final furlong with a clear lead then just lasted late. CARBON COUNTY stalked the pace outside, bid three wide in the drive and was slowly gaining on the winner late. HARLEY'S HEAT was void of early speed, angled to the middle of the course out of the second turn then finished willingly outside late. PURPLEGREENANDGOLD dueled to the stretch then slowly weakened. NO NAME TIGER was well placed behind the first flight, angled off the rail into the stretch but failed to respond. FOREVER VINDICATED failed to menace. BIG MINGUM raced evenly. CUP OF WHYS was well placed for six furlongs then faded. EXTENDED FAMILY showed little. STOLE MY SOUL stopped.
