WATCH ME GO was hung five wide early, continued along the outside while moving to the fore after a half then drew off smartly when roused. LITIGATE raced inside while stalking the leaders, was blocked and had to alter course outside in the drive then was up for the place late. LEGACY WILDCAT was well placed into the stretch but failed to respond when asked. CITY SAGE dueled to the stretch then steadied in traffic while tiring in the drive. PEACE CAT vied inside for more than a half then gave way. JACOBS KISS failed to menace. MEMORY ROAD was wide early but was no factor.
