WYNN A TOUR stalked the leaders for a half, bid four wide into the stretch then after gaining a short lead into the final furlong, just lasted over MONTELEONE late. MONTELEONE broke awkwardly, was far back for a half then settled and closed with a rush while angled outside late to just miss. LOST ONE'S HALO dueled throughout, also continued well through a long drive then just hung. BEST WESTERNER bid after three furlongs then flattened out. TIME TELLS ALL vied inside to upper stretch then weakened. PERFORMER'S IMAGE broke slow. STAGE DOOR MISTY was no factor. AMY'S BUDDHA stopped.
