BLUE CREEK raced close up inside early, got through along the rail to challenge in the turn then after dueling to late, edged clear under pressure. HIDDEN VOW set a solid pace three wide, resisted when challenged to late then hung while saving the place. SOUP DE VILLE was hung four wide much of the way and lacked a strong late response. WHEREINTHEWORLD saved ground into the turn, dropped back after a half then angled to the middle of the track in upper stretch but failed to gain. MASTER DAN was shuffled back early. CHANNELOFDREAMS showed speed to the turn then stopped.
