MINDY MICHELLE made a middle move then lodged a mild rally. AIDEN'S LIL DEVIL chased for a half then weakened. SET THE TREND set a moderate pace for a half then gave way. STORMY DELIVERY was through after a half. WICKED WOMAN OF NY was fractious in the gate and was through early.
