### Footnotes

CHARGING HOME raced well placed early, bid after six furlongs then drove clear leaving the furlong grounds and had enough left to prevail late. UNDER CONTROL (BRZ) was unhurried early, angled to the middle of the course in the drive then finished willingly outside late. FIFTH DISTRICT was unhurried early then got through in the drive and made up some ground but too late. TRUE STRIKE raced well placed early, bid into the stretch but was outkicked late. MZ'S DON ZULON raced evenly. FORBIDDEN DANCER failed to menace. GENERATION SPEED set a quick pace to the final furlong then gave way. BRAIN POWER chased then came up empty. BATON ON FIRE was through after a half. STACK THE DECK showed little.
