LADY OF PRESTIGE chased the early leaders, got through inside out of the turn to duel for the lead then slowly drew clear late under pressure. SANTIAGUERA made a middle move and was up for the place late outside. ALOHA PATTI dueled past the furlong marker then hung late. LISMORE BOUND dueled to mid stretch then weakened. NATURE COAST passed tiring rivals late. DREAMA chased to the quarter pole then faded. QUIBBLE'S REVENGE failed to menace. LIGHTING WANDA made a middle move through the turn then drifted wide and faded in the stretch. DONTTELLENORA showed little. RADIANT NANCY was no factor.
